1. BACKGROUND

The purpose of this scope is to procure, install, and integrate 4 off new combustible gas sensor elements suitable for detection of methane (CH₄) in the range of 0–100% Lower Explosive Limit (LEL). The sensors will be retrofitted onto an existing fixed gas detection transmitters unit currently installed within the facility's gas detection network and integrated into the site's Supervisory Control and Data Acquisition (SCADA) system using existing cabling and communication infrastructure.

The existing fixed gas detection systems installed on site comprises multiple transmitter units designed to accept interchangeable sensor modules. The installed transmitter heads currently lack a functional combustible gas sensing element. To restore methane detection capability, compatible replacement sensor elements must be supplied, fitted, and commissioned. Integration with SCADA must ensure real-time monitoring, alarm activation, and data trending in accordance with site operational and safety requirements.

2. Scope of Work

The service provider shall supply combustible gas sensors that meet the following minimum technical requirements:

INSTALLATION AND INTEGRATION

The contractor shall:

- 3.1. Fit the new sensor module into the transmitter head, ensuring correct seating and environmental sealing.
- 3.2. Verify digital communication between the sensor and transmitter.
- 3.3. Calibrate the gas detector to methane (CH₄) using certified calibration gas.
- 3.4. Integrate the sensor signal with the SCADA system using existing field cables and network architecture.
- 3.5. Conduct functional testing, confirming detection accuracy, alarm activation, and SCADA visibility.

DELIVERABLES

- 4.1. Supply of four (4) combustible gas sensor modules (0–100% LEL methane).
- 4.2. Installation and commissioning report including calibration certificate.
- 4.3. Proof of SCADA integration (screen capture or signal verification test sheet).
- 4.4. Updated device tag list showing restored methane detection point.

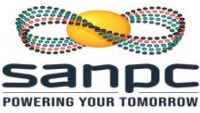

3.1. This Standard Bidding Document (SBD) must form part of all bids¹ invited.

3.2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.

3.3 Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:
