The South African National Petroleum Company (SANPC) is the newly established State-Owned Company and a subsidiary of the CEF Group of Companies.

BACKGROUND AND SCOPE OF WORK

1.BACKGROUND

Appointment of service provider for Clearing and Forwarding services for the handling and documentation of imports and exports and local South African movements of SANPC's lessee's petroleum products at all the SANPC's designated installations across the country.

2.SCOPE OF WORK

- 2.1 Supplier shall provide a suitably qualified and experienced logistics task force with all attendant facilities, equipment, procedures and controls necessary to handle all documentary clearing and forwarding tasks on behalf of SANPC. Specific experience is required with regard to the seamless handling and shipping of petroleum products for exports, imports and local South African destinations from SANPC installations across the country to various destinations worldwide or from any local destination. The supplier must have the facilities to do electronic submissions to our local customs authorities. Furthermore, a full detailed paper trail is required in the event of any audits.
- 2.2 SANPC shall provide the Supplier with all the relevant orders of product movements and relevant product movement schedules, as and when they become known, whereupon the Supplier shall assume total responsibility for providing a fully documented, dedicated, efficient and economical service, centred in South Africa, with an office or representation in the Western Cape. This will enable the timeous clearing and forwarding of all the products dictated by the Logistics Section(s).
- 2.3 Supplier's forwarders must be approved by SANPC and have the Local and Overseas Infrastructure necessary to provide SANPC with a complete Logistics solution.
- 2.4 Supplier's priced proposals, in accordance with the Scope of Work, shall ensure the most cost-effective and efficient movement of SANPC products, and materials under SANPC-issued movement instructions.
