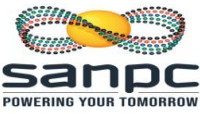

- 1.1. BIDS MUST BE DELIVERED BY THE STIPULATED DATE AND TIME TO THE CORRECT EMAIL ADDRESS AND/OR PLATFORM. LATE BIDS/RFQ WILL NOT BE CONSIDERED WHEN MAKING A DECISION TO AWARD.
- 1.2. ALL BIDS MUST BE SUBMITTED ON THE OFFICIAL FORMS PROVIDED – OR IN THE MANNER PRESCRIBED IN THE BID DOCUMENT.
- 1.3. THE 80 / 20 PREFERENTIAL POINT SYSTEM WILL BE APPLIED WHEREIN 80 POINTS IS FOR PRICE AND 20 POINTS IS FOR SPECIFIC GOALS.
- 1.4. POINTS SCORED FOR SPECIFIC GOALS WILL BE ADDED TO THE POINTS SCORED FOR PRICE AND THE TOTAL WILL BE ROUNDED OFF TO THE NEAREST TWO (2) DECIMAL PLACES.
- 1.5. A TENDER OR RFQ MUST BE AWARDED TO THE TENDERER WHO SCORE THE HIGHEST TOTAL NUMBER OF POINTS IN TERMS OF THE PREFERENCE POINT SYSTEM (PRICE AND SPECIFIC GOALS) UNLESS OBJECTIVE CRITERIA IN TERMS OF SECTION 2 (1)(F) OF THE PPPFA JUSTIFY THE AWARD OF THE TENDER TO ANOTHER TENDERER

- 1.9. THE BID MUST BE VALID FOR A PERIOD OF 60 CALENDAR DAYS FROM THE CLOSING DATE AND TIME

NATIONAL TREASURY'S CENTRAL SUPPLIER DATABASE

- 1.10. TENDERERS ARE REQUIRED TO SELF-REGISTER ON NATIONAL TREASURY'S CENTRAL SUPPLIER DATABASE ("CSD") WHICH HAS BEEN ESTABLISHED TO CENTRALLY ADMINISTER SUPPLIER INFORMATION FOR ALL ORGANS OF THE STATE AND FACILITATE THE VERIFICATION OF CERTAIN KEY SUPPLIER INFORMATION. 2.TAX COMPLIANCE

- 3.1 Changes by the Tenderer to its submission will not be considered after the closing date and time.

4. BINDING OFFER

- 4.1 Any Quotation furnished pursuant to this Request shall be deemed to be an offer. Any exceptions to this statement must be clearly and specifically indicated.

5.DISCLAIMERS

Please note that SANPC reserves the right to:

- 5.1 modify the RFQ's goods / service(s) and request Tenderers to re-bid on any changes;
- 5.2 reject any Quotation which does not conform to instructions and specifications which are detailed herein;
- 5.3 disqualify Quotations submitted after the stated submission deadline and/or submitted to the incorrect address;
- 5.4 not necessarily accept the lowest priced Quotation or an alternative bid;
- 5.5 place an order in connection with this Quotation at any time after the RFQ's closing date;
- 5.6 award only a portion of the proposed goods / services which are reflected in the scope of this RFQ;
- 5.7 split the award of the order/s between more than one Supplier/Service Provider should it at SANPC's discretion be more advantageous in terms of, amongst others, cost or developmental considerations or to achieve a specific goal;

1. purpose

To request the procurement of a centralized Third-Party Risk Management (TPRM) or Due Diligence Platform to identify, assess, monitor, and mitigate risks associated with SANPC's external partners, vendors, suppliers, or other third parties (both domestic and international) throughout the lifecycle of contractual relationships with the entity.

2. Background/context

SANPC is tasked with overseeing the strategic planning, coordination, and governance of South Africa's petroleum and gas resources. Thus, the entity engages in commodity trading and the commercial leasing of available ullage in various storage installations in its ownership. These activities are geared towards funding SANPC's strategic mandate and contributing towards the country's economic growth and development.

The aforementioned activities are achieved through contractual engagement with various external partners and to protect SANPC from third party risks including but not limited to financial, operational, regulatory, reputational and security risks, it is necessary to implement a robust **Automated Third-Party Risk Management System**. The system must align with South African statutory obligations and King IV principles of governance. Furthermore, the system must be embedded in risk-based thresholds for practical implementation and enable compliance with international global commodity trading and support ethical, transparent, and complaint business relationships.

The centralised system will assist SANPC to ensure all third parties comply with regulatory, operational, cybersecurity, and ethical standards in line with the entity's policies and procedures, by providing visibility, consistency, and control over third-party relationships. This system will be utilised to screen all suppliers, customers, intermediaries, and trading counterparties, involved in the procurement, sale, transportation, financing, storage, or exchange of commodities and related services.

3. SCOPE OF WORK

Supplier shall provide a robust third-party risk management system which encompasses but is not limited to the following capabilities:

1. Third-Party Identification & Onboarding

- Collects key data about potential vendors or partners.
- Automates questionnaires and documentation requests.
- Verifies business registration, ownership, and compliance status.

2. Risk Assessment & Scoring

- Evaluates third parties across multiple risk domains including, but not limited to
 - a) financial,
 - b) operational,
 - c) cybersecurity,
 - d) environmental,
 - e) social,
 - f) governance,
 - g) reputational,
 - h) legal,
 - i) ownership,
 - j) geopolitical.

- Generates risk scores or ratings using internal assessments and external data sources.
- 3. Due Diligence Automation
 - Conducts background checks, sanctions screenings, adverse media monitoring, politically exposed persons databases, credit ratings, financial statements and document reviews.
 - Integrates with data providers (e.g., Dun & Bradstreet, LexisNexis, Refinitiv) for continuous updates.
- 4. Monitoring & Alerts
 - Continuously monitors for changes in risk posture (e.g., regulatory violations, financial instability, data breaches).
 - Sends alerts when new risks or compliance issues arise.
- 5. Workflow & Governance Management
 - Supports structured approval workflows and audit trails.
 - Documents all decisions, assessments, and communications for compliance and accountability.
- 6. Reporting & Analytics
 - Provides dashboards, risk heat maps, escalation protocols and compliance reports.
 - Supports internal and regulatory reporting requirements
 - The ability to integrate with existing internal systems.

1.3 The bid of any bidder may be disregarded if that bidder, or any of its directors have-

- 2.3.1 Abused the institution's supply chain management system
- 2.3.2 Committed fraud or any other improper conduct in relation to such system; or
- 2.3.3 Failed to perform on any previous contract.

2.4 In order to give effect to the above, the following questionnaire must be completed and submitted with the bid.

1. GENERAL CONDITIONS

1.1 The following preference point systems are applicable to invitations to tender:

- the 80/20 system for requirements with a Rand value of up to R50 000 000 (all applicable taxes included); and
- the 90/10 system for requirements with a Rand value above R50 000 000 (all applicable taxes included).

1.2 To be completed by the organ of state

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
 - (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or

ANNEXURE 5

Certificate of Independent Bid Determination (SBD 9)

- 3.1. This Standard Bidding Document (SBD) must form part of all bids¹ invited.
- 3.2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
- 3.3 Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:
- disregard the bid of any bidder if that bidder, or any of its directors have abused the institution's supply chain management system and or committed fraud or any other improper conduct in relation to such system.
 - cancel a contract awarded to a supplier of goods and services if the supplier committed any corrupt or fraudulent act during the bidding process or the execution of that contract.

² Bid rigging (or collusive bidding) occurs when businesses, that would otherwise be expected to compete, secretly conspire to raise prices or lower the quality of goods and / or services for purchasers who wish to acquire goods and / or services through a bidding process. Bid rigging is, therefore, an agreement between competitors not to compete.
