BACKGROUND

SFF appointed an Environmental Assessment Practitioner (EAP) to facilitate the transfer of Avedia's Environmental Authorization (EA) to SFF, making SFF the new authorization holder for the LPG pipeline and Berth 104 project.

The Western Cape Department of Environmental Affairs and Development Planning (DEA&DP) has approved the transfer, subject to the condition that all Interested and Affected Parties (I&APs) registered during Avedia's original Environmental Impact Assessment (EIA) process be notified of the change in authorization holder.

SFF has encountered significant challenges in fulfilling this condition due to the following constraints:

- The original I&AP database (conducted in 2012/2013) contains only the names of registered participants, with no accompanying contact details, making direct notification impossible.
- The original EIA consultant, no longer retains any records or databases from the previous process.

Given these limitations, SFF engaged DEA&DP to explain the situation and to explore alternative methods to meet the notification requirement. Following discussions, the Department agreed that SFF could meet the condition by publishing a public notice of the transfer decision in a widely accessible platform, such as a local or national newspaper, to ensure reasonable effort is made to inform all potentially affected parties.

SCOPE OF WORK

The competent authority for this project is the Western Cape Department of Environmental Affairs and Development Planning (DEA&DP) who has granted SFF the transfer of Avedia's authorization into the new holder SFF subject to the condition that all Interested and Affected Parties (I&APs) registered during Avedia's original Environmental Impact Assessment (EIA) process be notified of the change in authorization holder.

The appointed service provider will be required to publish a notice in a newspaper with a nationwide circulation, ensuring that the publication mostly reaches the Saldanha area which is the location of the proposed LPG pipeline project.

- 3.1. This Standard Bidding Document (SBD) must form part of all bids¹ invited.
- 3.2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
