Please note that SANPC reserves the right to:

- 5.2 reject any Quotation which does not conform to instructions and specifications which are detailed herein;
- 5.3 disqualify Quotations submitted after the stated submission deadline and/or submitted to the incorrect address;
- 5.4 not necessarily accept the lowest priced Quotation or an alternative bid;
- 5.5 place an order in connection with this Quotation at any time after the RFQ's closing date;
- 5.6 award only a portion of the proposed goods / services which are reflected in the scope of this RFQ;

1. BACKGROUND

The South African National Petroleum Company (SANPC) is the newly established State-Owned Company and a subsidiary of the CEF Group of Companies.

2. SCOPE OF WORK

1. Purpose

The purpose of this requisition is to appoint a **competent and legally compliant service provider** to conduct the **inspection, servicing, maintenance and certification of fire extinguishers**, in compliance with the **Occupational Health and Safety Act, 85 of 1993**, and applicable **SANS standards**.

2. Scope of Equipment

This requisition applies to all portable fire extinguishers on site, including but not limited to:

1. 5X 2.5kg DCP Fire Extinguisher annual service
2. 5X 2.5kg bracket supply
3. 12X 9kg DCP Fire Extinguisher annual service
4. 3X 9kg DCP Fire Extinguisher annual
5. 15X 9kg fire extinguisher cabinet supply
6. 3X 5Kg CO2 supply
7. 3X 5kg CO2 annual service
8. 4X 50kg FOAM Fire Extinguisher annual service

3. Scope of Work

The appointed service provider shall carry out the following:

3.1 Inspection & Servicing

- Visual inspection of extinguishers for damage, corrosion or leakage
- Verification of correct extinguisher type for fire risk
- Checking of pressure, seals, hoses and nozzles
- Weighing of CO₂ extinguishers
- Servicing in accordance with manufacturer requirements

3.2 Maintenance

- Annual servicing of all fire extinguishers
- Refilling or replacement where required
- Immediate removal from service of defective extinguishers

3.3 Identification & Signage

- Clear labelling of each extinguisher with:
 - Service date
 - Next service due date
 - Service provider details
- Verification that fire extinguisher signage is visible and compliant

4. Legislative & Standards Compliance

All work shall comply with, but not be limited to:

- **Occupational Health and Safety Act, 85 of 1993**
 - Section 8 – General duties of employers
- **SANS 1475** – Portable fire extinguishers
- **SANS 10105** – Installation, maintenance and location of extinguishers
- Manufacturer specifications

5. Inspection & Servicing Intervals (Audit Ready)

- **Annual servicing** – By competent service provider
- **Hydrostatic testing** – As per SANS requirements (usually every 5 years, extinguisher type dependent)

6. Deliverables

The service provider shall provide:

- Fire extinguisher service certificates
- Updated fire extinguisher register
- Defect report with corrective actions
- Service labels attached to each extinguisher
- Proof of compliance with SANS standards

All documentation must be suitable for **Department of Employment & Labour inspections and audits.**

ANNEXURE 5

- 3.1. This Standard Bidding Document (SBD) must form part of all bids¹ invited.
- 3.2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
- 3.3 Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:
