- 1.3. THE 80 / 20 PREFERENTIAL POINT SYSTEM WILL BE APPLIED WHEREIN 80 POINTS IS FOR PRICE AND 20 POINTS IS FOR SPECIFIC GOALS.

- 5.2 reject any Quotation which does not conform to instructions and specifications which are detailed herein;
- 5.3 disqualify Quotations submitted after the stated submission deadline and/or submitted to the incorrect address;
- 5.4 not necessarily accept the lowest priced Quotation or an alternative bid;
- 5.5 place an order in connection with this Quotation at any time after the RFQ's closing date;
- 5.6 award only a portion of the proposed goods / services which are reflected in the scope of this RFQ;

1. BACKGROUND

The South African National Petroleum Company (SANPC) is the newly established State-Owned Company and a subsidiary of the CEF Group of Companies.

1. Purpose

The purpose of this is to appoint a **competent and legally compliant service provider** to conduct **inspection, testing, load testing and certification** of the **HI-AB truck-mounted crane and associated lifting equipment**, in compliance with the **Occupational Health and Safety Act, 85 of 1993**, and **Driven Machinery Regulations (DMR)** of South Africa

2. Scope of Work

The appointed service provider shall carry out the following:

2.1 HI-AB Truck / Truck-Mounted Crane

- Visual and functional inspection of the HI-AB crane
- Operational testing of:
 - Hydraulic system
 - Controls and safety devices
 - Load moment indicator (where fitted)
 - Emergency stop systems
- **Load testing** in accordance with manufacturer specifications and DMR requirements
- Structural inspection (boom, pins, welds, slewing mechanism)
- Stability and outrigger system inspection
- Identification and tagging of defects
- Issuing of **inspection and load test certificates**

2.2 Lifting Equipment & Accessories

Inspection and testing of, but not limited to:

- Slings (wire rope, chain, synthetic)
- Shackles
- Hooks
- Lifting beams / spreader bars
- Lifting chains
- Any other lifting tackle associated with the HI-AB truck

All equipment shall be:

- Inspected for wear, deformation, corrosion, and damage
- Load tested where required

Clearly tagged with **inspection status and expiry date**

2. Legislative Compliance

All inspections and certifications must comply with:

- **Occupational Health and Safety Act, 85 of 1993**
- **Driven Machinery Regulations (DMR)** – especially Regulations 18 & 19
- Relevant **SANS standards**
- Manufacturer specifications

4. Deliverables

The service provider must provide the following upon completion:

- Defect list with risk rating and corrective actions

- Service report signed by a competent person

All documents must be suitable for **audits, inspections and legal compliance**.

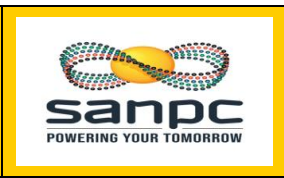

ANNEXURE 5

Certificate of Independent Bid Determination (SBD 9)

- 3.1. This Standard Bidding Document (SBD) must form part of all bids¹ invited.
- 3.2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
- 3.3 Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:
- a. disregard the bid of any bidder if that bidder, or any of its directors have abused the institution's supply chain management system and or committed fraud or any other improper conduct in relation to such system.
 - b. cancel a contract awarded to a supplier of goods and services if the supplier committed any corrupt or fraudulent act during the bidding process or the execution of that contract.

Bid rigging is, therefore, an agreement between competitors not to compete.
