The solution must facilitate the entire meeting lifecycle from preparation through to post-meeting follow-up and action management.

SANPC is currently utilizing BoardPAC as its board management system and requires seamless data migration to the new platform to ensure business continuity and preservation of historical board records.

2. OBJECTIVES

The primary objectives of this procurement are to:

- Eliminate paper-based board workflows and transition to a secure digital platform

3.2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
